How does Amerant protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>Amerant uses cookies as part of our interaction with your browser. These cookies do not collect personal identifiable information.</p>

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><i>Our affiliates include financial companies such as Amerant Mortgage, LLC, and Amerant Investments, Inc.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><i>Amerant Bank, N.A. does not share with nonaffiliates so they can market to you.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"><i>Our joint marketing partners include financial companies.</i>
Other Important Information	
<p>This Privacy Notice applies to all Amerant Bank, N.A.'s consumer products or services that may be offered or made available. This Privacy Notice does not apply to any other product or service that you may obtain from Amerant Bank, N.A..
